Nominate Your Volunteers for the Enduring Service Volunteer Award

You have an easy opportunity to nominate your best volunteers for a nationwide award! The Enduring Service Volunteer Award was established in January 2016 by the Corps Foundation. It honors long-term service and outstanding accomplishments by individuals and families at U.S. Army Corps of Engineers (USACE) lakes and waterways. The award is intended as a lifetime achievement award for exceptional volunteers who have made a positive difference in the lakes and waterways and the communities, they serve by volunteering for a period of 6 years or more. Recognizing the excellence of these individuals and families, the award highlights the long-term dedication and devotion of those who support USACE lakes and waterways. A maximum of two individual or group awardees will be recognized.



USACE parks benefit from more than 45,100 volunteers donating over 1.5 million hours to help USACE meet its recreation and stewardship goals. This equates to approximately 27% of the USACE workforce!

Our Enduring Service Award was

originated in 2016 to annually honor volunteers who serve at least six years at a USACE project. We coordinate the award applications. Recipients are recognized in a special ceremony involving the local USACE project and communities where they live. In 2020, we plan to continue this popular award to a volunteer group who work just for the love of their local public lands.

AWARD NOMINATION

Nominations will be accepted between September 15 and December 30, 2020. Nominations will be reviewed and winners will be announced in spring of the following year.

AWARD ELIGIBILITY

This award recognizes the outstanding contributions by individuals or families of dedicated volunteers who provide essential services to USACE operated lakes and waterways. The Corps Foundation Enduring Service Volunteer Award may be given to an individual or family performing voluntary services that meet the criteria below.

CRITERIA FOR RECOGNITION

This award will be presented to an individual or family who demonstrates long-term dedication, innovation, and excellence in volunteer service; and who have achieved results in such areas as environmental stewardship, conservation, interpretation, education, recreation, safety, administration, and community engagement. Additionally, these volunteer efforts should contribute to the advancement of:

- The mission of the Corps Foundation: "The Corps Foundation engages the public to ensure the environmental health and recreational enjoyment of our nation's lakes, lands, and waterways administered by the US Army Corps of Engineers".
- Positive relationships and collaboration between USACE management, the visitors, and the local community.
- Public knowledge of and involvement in the USACE natural resources management program

Nominees are volunteers who have demonstrated significant dedication by volunteering and providing leadership for a minimum of 6 years. Nominees with less than 6 years of service will not be considered.

Life Jackets Worn...Nobody Mourns Campaign Bandanas Distributed

A conversation between the Corps Foundation's Board Chairman, Greg Miller and Special Programs Director, Rachel Garren sparked an idea last spring to purchase Life Jackets Worn...Nobody Mourns campaign bandanas to use as optional face coverings

during the COVID-19 pandemic. USACE Headquarters liked the idea, so National Water Safety Program Manager Pam Doty agreed to coordinate the delivery to USACE offices.

Bandanas were not originally budgeted as a grant product purchase this year. Grant funds originated from the Sport Fish Restoration and Boating Trust Fund, administered by the U.S. Coast Guard (USCG), so USCG had to approve a shift in funds from other items in the budget to purchase bandanas. The USCG agreed that this was a great idea. The pandemic eliminated the need for grant-related travel that was budgeted for this year so those funds and some funds from another planned product purchases were combined to come up with \$12,500 to purchase bandanas. This was quickly advertised to bidders and 10,584 bandanas were purchased, boxed, and shipped to the USACE National Water Safety Program for distribution. In slightly over a month from start to finish, high-quality cotton, 22" square bandanas were distributed to 176 USACE offices for employees and others to use as optional face coverings.



Huge Success-2020 Life Jacket Video Contest



The 2020 Life Jacket Video Contest has ended and we were extremely pleased with the entries we received. Many of the video entries will be posted during the 2021 recreation season at Please Wear It on Facebook, Twitter, and Instagram. The 1st place winners will be posted on social media in October 2020. The first-place, 25-second-video winner of \$2,500 is Alexander Goldstein from Scarsdale, NY, and the first-place, 55-second-video winner of \$5,500 is Jessica Couture from Brooksville, FL. We were so impressed with some of the video entries that we created honorable mention monetary prizes for three of the 55-second videos and three of the 25-second videos. The 55-second honorable mentions will receive \$500 each and the 25-second honorable mentions will receive \$250 each.

The Life Jackets Worn...Nobody Mourns campaign, including this contest, are managed through a partnership between the U.S. Army Corps of Engineers and the nonprofit Corps Foundation. Prize money is funded through a Corps Foundation grant from the Sport Fish Restoration and Boating Trust Fund, administered by the U.S. Coast Guard.



Park Ranger David White presented the volunteer coins on 20 August and provided the attached pictures and citations below for Warren Brawley (left) and Richard Whitehead (right). Thanks to David White and Francis Farrell for this nomination.

Richard "Ricky" Whitehead filled multiple roles at the Black Warrior and Tombigbee Lakes project. He has been a facility cleaner at Jennings Ferry Campground, Foscue Creek Campground, and Spillway Falls Park. He performed duties to make improvements to each of the parks as well as maintaining campground cleanliness. He is always ready to lend a helping hand to project staff or visitors.

Soon after the Ricky's arrival at Black Warrior and Tombigbee Lakes we realized that his talents would be very beneficial. He assisted with multiple projects on top of his normal facility cleaning duties. He maintained four miles of walking/hiking trails, cleaned and stabilized one mile of shoreline, assisted in planting 8.25 acres of wildlife food plots, and aided in prescribed burns of native grasses. These yearly burns help eliminate invasive and nuisance species, allowing native grasses to provide habitat for pollinators, songbirds, turkey, quail, whitetail deer, and other species. Without his help, many of these projects would take much longer to complete or simply would not be done at all.

Ricky is among the hardest workers the Black Warrior and Tombigbee Lakes staff has ever seen. Many improvements have been made to the project lands due to his volunteering. Being always eager to help and one of the most pleasant personalities to be around make Ricky a priceless addition to the Corps of Engineers.

When Warren Brawley first arrived at Black Warrior and Tombigbee Lakes project, he and his wife were operating the gatehouse at Foscue Creek Park and Campground. Visitors to the campground praised their friendly personalities. They were excellent in gatehouse operation, collecting funds, maintaining grounds, and communicating with the park campers and visitors about the programs of Corps of Engineers. The following year he returned to maintain our day use park, Spillway Falls. He maintained the extensive trails located in the park as well as cleaned the restrooms, pavilion, and kept the grounds clear of litter. During his time at Spillway Falls, the covolunteer had to leave due to family responsibilities. Warren stepped up to fill this vacant role and maintained the park on his own. His efforts allowed us to keep the park open. He is a great asset to the Black Warrior and Tombigbee Lakes project.
