

Corps Foundation Welcomes New Board Member – Avis Kennedy!



The Corps Foundation Board of Directors is excited to welcome Avis Kennedy as it's its newest member to the Board!

Avis worked for 33 years in the U. S. Army Corps of Engineers Natural Resources Management Program in its Nashville District- including positions as Park Ranger, Outdoor Recreation Planner, Conservation Biologist, and 15 years at the Chief of Natural Resources Management Branch for the Nashville District.

Along the way, she also served in temporary positions as Planner, Resource Manager at Cordell Hull and J. Percy Priest Lakes, and Chief, Regulatory Branch. In 2008, she served temporarily as the national Business Line Manager for Stewardship in the Corps Headquarters, and was awarded the Nashville District's Distinguished Civilian Award. Although Avis retired in 2011, she decided to return to work In 2017 to take a job as Project Manager for revision of the Raystown Lake Master Plan in Baltimore District. The Foundation's Enduring Service Volunteer Award honors the long-term service and outstanding accomplishments of volunteer individuals and families. The Corps Foundation announced the 2021 "Enduring Service" awardees in our summer newsletter. The awards were subsequently presented at the lake projects and we would like to share some photos taken during the presentations. This year's award winners are:

Ray Garner, 20 years of dedicated service and more than 25,000 hours as a volunteer at Eufaula Lake, Oklahoma. Mr. Garner has proven himself an invaluable asset and instrumental member in the continued success and operation of the Eufaula Lake Project.

Chip Parrill and Kathy Parrill, 7 years of dedicated service at Jennings Randolph Lake, West Virginia. The Jennings Randolph Lake has benefited immensely from the Parrill's community involvement, compassion and dedication to project and its visitors.



USACE Baltimore District Lt. Colonel Myers and Deputy Chief Lacy Evans were on site to present the Corps Foundation Enduring Service award to Chip and Kathy Parrill on July 23, 2022. The Parrill's were selected as the 2021 Enduring Service Award couple of the year for their outstanding dedication and service to the Corps and Jennings Randolph Lake. Members of their family and friends attended the ceremony to see them receive this award.



Ray Garner, a Eufaula Lake volunteer with more than 20 years of service, was selected as a 2021 Corps Foundation Enduring Service Award recipient. On Wednesday, 20 July 2022, Tulsa District Office and Eastern Area leadership gathered to present Ray with his plaque and \$250 cash award.

The Corps Foundation initiated the National Enduring Service Volunteer Award to honor the long-term commitment and outstanding accomplishments of individuals and families who volunteer at Corps lakes, lands and waterways. The award recognizes the legacy of volunteers who serve at least six years at a US Army Corps of Engineers (USACE) project. Since the beginning of the award the Corps Foundation has partnered with Bass Pro Shops to annually recognize the long-term service and accomplishments by volunteers at USACE lakes who have achieved results in such areas as fisheries, conservation, education, recreation, safety and community engagement.

Congratulations to Lesley McClintock

We received an early report that Lesley McClintock, former park ranger at Bonneville Lock and Dam, won first place in the National Association for Interpretation (NAI) Media Awards in the "Pandemic Pivot" category. As the name suggests, this was a change in plans – a pivot - resulting from the pandemic. In this case, Lesley, supported by staff from Natural Resources Management and Interpretation plus volunteers, painted a mural at the Bonneville Lock and Dam Visitor Center Located on the Columbia River. This was no ordinary mural. This one was 135 feet long, 8.5 feet high and visually portrayed the Journey of the Pacific Salmon. The location was along a sheltered outdoor ramp where visitors access a building featuring an underwater view of a fish ladder. The Corps Foundation congratulates Lesley and all involved on this magnificent accomplishment.

Life Jackets Worn... Nobody Mourns Campaign Grants 5 & 6 Updates

In late 2022, The Corps Foundation, completed their 5th grant, funded Sport Fish Restoration and Boating Trust Fund, administered by the US. Coast Guard (USCG) and began work on their 6th grant, which is also a three-year grant. Current grants funds include \$150,000 each year to promote the award-winning Life Jackets Worn... Nobody Mourns campaign targeting high-risk, adult boaters in partnership with the U.S. Army Corps of Engineers (USACE).

By the end of our 5th grant, there was phenomenal growth on the **Please Wear It** social media channels (Facebook, Instagram, and Twitter) and Facebook had attracted 21,863 followers. On social media, we will continue to promote two big giveaways each year and the Life Jacket Video Contest in partnership with USACE.

The completed grant involved the purchase of campaign promotional products that included logo patches, long-sleeve t-shirts, 22-inch-square bandanas, 2 feet by 4 feet vinyl banners, beach towels, dry bags, vehicle windshield sunshades, and short-sleeve t-shirts. Promotional products will continue to be purchased and distributed through social media giveaways and to USACE to distribute primarily through "I Got Caught" initiatives.

Grant funds have been used to purchase campaign advertisements through a variety of avenues like state fishing guides, movie theater ads, and billboards in areas where USACE lakes and rivers have the most water-related fatalities. In the new grant, we will explore other advertising avenues to promote the campaign.

The USCG reported a 25.1% increase in boating fatalities in 2020 compared to 2019, and USACE reported a 22% increase in water-related fatalities in the same time frame. Despite those increases, there was a 7% decrease in USACE water-related fatalities when comparing five years prior to the launch of this campaign in 2016, to five years post-campaign launch. This downward trend is remarkable considering the 2020 increase in fatalities and growth in water-based recreation.

Campaign success is thanks to all those who work together to promote the campaign, especially USACE. However, many lives are still lost each year on our nation's waterways so there's work to be done and we need your continued help. Life Jacket Video Contest 2022 Results & 2023 Launch

The 2022 Life Jacket Video Contest had a double winner for the first time! Lauren Stamper won \$8,000 for her 25- and 55-second videos. We had 24 videos entered by 18 entrants.

The 2023 Life Jacket Video Contest was launched on October 19, 2022 and it ends on September 8, 2023. The winner(s) of the 25-second-long video will get \$2,500 and the 55-second-long video winner(s) will get \$5,500. The Life Jackets Worn...Nobody Mourns campaign, including this contest, are managed through a partnership between the U.S. Army Corps of Engineers National Operations Center for Water Safety and the Corps Foundation. Prize money for the video contest is funded through a Corps Foundation grant from the Sport Fish Restoration and Boating Trust Fund, administered by the U.S. Coast Guard. Thanks to everyone, including the U.S. Army Corps of Engineers offices that helped to promote the contest.
