### A Special Connection: Natural Resource Management Employees and the Corps Foundation

Board members for the Corps Foundation regularly travel the country to meet the men and women who manage recreation areas for the U.S. Army Corps of Engineers. A common question board members receive relates to membership in the Foundation as a non-profit partner to USACE- "Are USACE employees allowed to join the Foundation"? The answer is yes, please do!

Why? The prohibition of government employees from soliciting for donations and legislative advocacy is the #1 and #2 reasons those employees should join. Employees are not allowed to go to the local boating shop to solicit for donated life jackets, but the Foundation can. The Foundation has the non-profit legal status to ask private donors for assistance toward the good works of the field employees. The Foundation supports the volunteer and water safety programs at local field projects. It is also the voice of advocacy for new legislation and authorities that benefit the recreation program within the Corps. What happens in the halls of Congress can directly filter down to the field level. Since 2007, the Foundation has been instrumental in advocating for changes in assessing the recreation facilities managed by USACE for improved awareness of deferred maintenance, introduced legislation for fee retention and changes to the Cooperative Joint Management authorities.

The list is long to bring the USACE recreation program up to the level of other Federal public land agencies. You have the Foundation's permission to join an organization that extends an employee's influence beyond the boundaries of a field project. If you are a USACE employee- please become a member so we can continue our good work that benefits you!!!



## LAKES Act Introduced into the House of Representatives!

Congressmen Steve Womack (R-AR-3), Bruce Westerman (R-AR-4), and Jared Huffman (D-CA-2) introduced H.R. 6906, The Lake Access Keeping Economies Strong (LAKES) Act on January 4, 2024.

#### The LAKES Act would:

- Allow USACE to retain 80% of recreation fees collected onsite for operation and management expenses at that location.
- Amend the Challenge Cost Sharing Cooperative Management Agreement authority to allow nonprofit entities to enter into cooperative agreements.
- Keep resources and decision-making related to operation and maintenance of recreation facilities with local managers.



## Restitution Agreement and Donation for Huntington District



The Corps Foundation accepted a large donation as part of a plea agreement in connection with the trespass and illegal dumping of catfish in a river in the state of West Virginia. The Corps Foundation subsequently used the funds to partner with Clendening Lake to enhance a USACE Handshake project to complete a 1.1-mile wetland loop trail. The donated funds were used to purchase interpretive signs to highlight different ecosystems and habitats, and a permanent spotting scope that allows visitors to overlook an osprey nesting platform, wetland, and Clendening Lake. The three 18 x 24 interpretive signs describing forest ecology, wetland ecology, and pollinator habitat are pictured below. The signs were installed on the wetland trail in the summer of 2023.
