How-to-Use the Toolkit:

Toolkit contains Sections-Tabs 1, 2, 3, 4. Each covers specific information including search links, source information and data.

Section-Tab 1: Search Links:

Links to Corps Foundation Website and Facebook Page to view currently posted Calls for Action, Advocacy Alerts and Appeal Letters. Postings are titled "Advocacy Alert! Please U.S. Contact Congressional Legislators Immediately".

Postings include a suggested appeal letter for contacting legislators and encouraging support of proposed legislative language and pass legislation favorable to the USACE NRM program. Personalize each letter to include your and your organization's viewpoint. Participation increases an advocacy issue's visibility, significance and a resulting positive outcome.

Section-Tab 2: Target Legislation and Advocacy Issues:

Defines current 2025-2026 Corps Foundation Advocacy Issues. These issues target specific legislation, encouraging beneficial changes to USACE NRM's ability to maintain or advance programs from recreational facility improvements to wildlife protection and habitat enhancements. The following is a summary of listed advocacy issues in Section-Tab 2.

Establish a Public Lands Restoration Fund: Provide authority to address recreation facilities maintenance backlog. Direct funds retained for extraction of resources on public lands similar to funding provisions in the Great American Outdoors Act.

Cooperative Agreements: Provide the ability to spend appropriated Recreation and Environmental Stewardship funds to set up cooperative agreements.

Federal Lands Transportation Program: Dedicate \$30 million for each of fiscal years 2026 - 2030. Provides critical investments for road, bridge, tunnel and parking lot projects that support access to public recreation.

Legislation: Appropriations Bill Fiscal Year 2026: Provide essential Recreation Program funding.

Operations and Maintenance Funding: Allocate not less than \$295,000,000 in FY-2026 Recreation Program funding to continue the existing level of operation, maintenance, and repair of recreation facilities and public access. This represents the same amount as enacted for FY 2022's Recreation Program budget.

Infrastructure Maintenance and Repair Funding: Increase FY 2026 Recreation Program funding in the Operations and Maintenance Account, Other Authorized Project Purposes to allocate not less than \$40,000,000 to continue the repair of existing recreation facilities including unfunded infrastructure maintenance to sustain existing facilities at full capacity.

Corps Foundation 2025-26 Advocacy Appeals

Contact your Senator and Congressional representative to support lakes and lands managed by the U.S Army Corps of Engineers; support adequate staffing and return probationary workers to field offices.

2025-26 Requests Planned but not yet Initiated:

(1). Request: Establish a Public Lands Restoration Fund

What: Establish a funding program for US Army Corps of Engineers (USACE) Recreation business line backlog maintenance needs similar to the Great American Outdoors Act. Provide authority to establish, fund, and provide for the use of amounts in a US Army Corps of Engineers (USACE) Public Lands Restoration Fund to address recreation facilities maintenance backlog. The fund must be used for priority deferred recreation facility maintenance. For each of fiscal years 2026 through 2030, there shall be deposited in the Fund an amount equal to 50 percent of all energy development revenues due and payable to the United States from oil, gas, coal, or alternative or renewable energy development on USACE Federal land and water credited, covered, or deposited as miscellaneous receipts under Federal law in the preceding fiscal year. Amounts deposited in the Fund shall be available to the Assistant Secretary of the Army, Civil Works, without further appropriation or fiscal year limitation. The Assistant Secretary of the Army, Civil Works may accept public cash or in-kind donations that advance efforts to reduce the deferred maintenance backlog; and encourage relevant public-private partnerships.

Why: This restoration fund would be dedicated to the elimination of unfunded infrastructure needs in support of public recreation facilities managed by USACE, similar to the Great America Outdoors Act.

Impact: Directs funds retained for extraction of resources on public lands to the benefit of the public using the recreation facilities similar to the funding provisions in the Great American Outdoors Act.

Process: Request the Committee/Subcommittee reach out to USACE for drafting services or identify options to bring USACE in line with the benefits the other land management agencies receive.

(2). Request: Provide ability to spend appropriated Recreation and Environmental Stewardship funds to set up cooperative agreements.

What: Provide authority for the ability to spend appropriated US Army Corps of Engineers (USACE) Recreation and Environmental Stewardship funds to set up cooperative agreements with adjacent federal or non-federal public entities for mutually beneficial work such as fire management, invasive species management, endangered species management, consolidated contract services for cleaning, mowing, janitorial, etc. on USACE and partner lands. This authority would be somewhat similar to the Good Neighbor Authority used by the US Forest Service and Bureau of Land Management.

Why: Many lands managed by USACE are adjacent to federal and non-Federal public entities that manage similar environments and facilities. USACE is prohibited from spending appropriated funds off of COE lands. This authority would streamline operations and save appropriated funds by allowing multiple agreements for mutually beneficial goals.

Impact: Saves appropriated funds and streamlines operations.

Process: Request the Committee/Subcommittee reach out to USACE for legislative drafting services.

(3). Request: Establish US Army Corps of Engineers (USACE) Federal Lands Transportation Program (FLTP) Dedicated Set Aside

What: Request Committee consider legislation or other actions that establishes a set aside for USACE at \$30 million annually. For USACE as currently enacted, H. R. 3684 provides in Federal Highway Administration, Highway Infrastructure Program or Division A, Sec 1101, that not less than \$7,000,000 shall be made available for each Federal agency otherwise eligible to compete for amounts made available under that section for each of fiscal years 2026 through 2030.

Why: Despite the economic benefits of the USACE recreation program and the extensive number of transportation infrastructure assets managed by the agency, USACE does not receive set-aside funding from FLTP to improve access to federal lands and waters, while agencies such as Fish and Wildlife Service and US Forest Service that attract a smaller share of visitors each year receive this set-aside funding. Even with a smaller land footprint, USACE transportation assets see a much higher use than the other federal agencies. As USACE deferred maintenance costs continue to stack up, this additional funding would provide critical investments in the highest priority road, bridge, tunnel and parking lot projects that support access to USACE recreation access points.

Impact: By not reassessing agency allocations for maintenance funding post-GAOA, these funding inequities only further exacerbates transportation infrastructure assets, leaving USACE to struggle with facing a worsening backlog while managing increased demand for recreation opportunities at USACE-managed sites.

Process: Request the Committee/Subcommittee reach out to USACE for drafting services or identify options to bring USACE in line with the benefits the other land management agencies receive.

(4). Request: Provide Essential Recreation Program Funding - Appropriations Bill Fiscal Year 2026

a. USACE Budget, Recreation Business Line, Operations and Maintenance Account

Ask Congress to consider and support an amendment in the forthcoming FY 2026 Appropriations Bill, that Recreation Program funding be allocated at not less than \$295,000,000 to continue the existing level of operation, maintenance, and repair of recreation facilities and public access. This represents the same

What: Request an explanatory statement that FY 2026 Recreation Program funding be allocated at not less than \$295,000,000

Why: Funding the FY 2026 Recreation Program at this level is necessary to continue the existing level of operation, maintenance, and repair of recreation facilities and public access.

In a scenario with an amount proposed at less than 295 million, the Recreation program will experience major reductions to routine labor and visitor services. The program would be left without basic funding for operations and maintenance including day-to-day labor for park rangers, maintenance staff for management of public use areas, staff support for management of volunteers and partnerships, limited or complete closure of visitor center operations, and contract support for trash removal, janitorial, mowing, and gate attendants.

Impact: Funding at \$295 million allows USACE to continue to provide public access at acceptable levels and avoids an increase in deferred facility maintenance backlog.

Process: Request the Committee/Subcommittee reach out to USACE for drafting services or identify options to bring USACE in line with the benefits the other land management agencies receive.

b. USACE Budget, Operation and Maintenance Account, Other Authorized Project Purposes

Ask Congress to consider additional funding in the US Army Corps of Engineers (USACE) Operations and Maintenance Account, Other Authorized Project Purposes that not less than \$40,000,000 be allocated for the Recreation Business Line.

What: Request explanatory statement that of the additional funding provided in the Operations and Maintenance Account, Other Authorized Project Purposes, not less than \$40,000,000 shall be allocated for US Army Corps of Engineers Recreation Business Line to continue the operation, maintenance, and repair of existing recreation facilities and public access including unfunded infrastructure maintenance needed to sustain existing facilities at full capacity.

Why: USACE hosted a total of 272 MILLION visitors, in 2021 an increase of 16.3 million in just one year. USACE is the #1 Federal provider of water based outdoor recreation. As a result of increased visitation, many parks reached or exceeded their designed capacity every weekend. Visitor assistance and public safety is the primary concern for the USACE recreation mission. As such, Park ranger efforts were diverted to traffic management while visitors accessed areas closed, restricted or not designed for recreation use. Many parks were forced to deal with increase in vandalism, property damage, illegal access, and increases in trash and litter and traffic accidents. Impacts to infrastructure, maintenance and repair far surpassed the level of funding to manage the facilities safely. USACE NRM program accounts are underfunded, and the agency is often excluded from benefits of other agencies through significantly impactful federal lands and waters policy and funding mechanisms such as the Federal Lands Transportation Program, the Federal Lands Recreation Enhancement Act and the Great American Outdoors Act (GAOA). By not reassessing agency allocations for maintenance funding post-GAOA, these funding inequities will be further exacerbated leaving USACE with a worsening maintenance backlog while managing increased demand for recreation opportunities at USACE-managed sites.

Increasing Recreation Business Line funding requires the overall additional Operations and Maintenance Account, Other Authorized Project Purposes funding amount to increase in line at least with the Recreation Business Line increase. This directed amount of funding to the Recreation program is above that recommended by the Administration.

Impact: Additional funding allows USACE to continue to provide public access at acceptable levels and avoids an increase in deferred facility maintenance backlog.

Process: Request the Committee/Subcommittee reach out to USACE for drafting services or identify options to bring USACE in line with the benefits the other land management agencies receive.
